
Dates to Remember...

### Do you have bulk trash?

The City of Wylie has a contract with CWD for bulk trash pickup. If you have bulk items to have picked up, **you must call CWD to schedule**. Please call 972-392-9300 by 5pm on Tuesdays to schedule a pickup by the end of same week. **The trash will not be picked up unless you call.** CWD also added an optional drop off for bulk trash on Saturdays at the City of Wylie Public Works at 949 Hensley. Items may be dropped off between 8:00 am and noon.



# Did you know that the City of Wylie has leash laws for your pets?

The HOA has received several complaints regarding homeowners letting their dogs out to do their business in a neighbor's yard. This is against city code. Please leash and pick up after your pets.
